# VERY IMPORTANT !!! USBC PEPSI GUIDELINES

#### ALL bowling will be on a scratch basis

BIRTHDATE RANGES FOR THE AGE DIVISIONS WILL BE AS FOLLOWS. EACH AGE DIVISION WILL HAVE A SEPARATE BOYS AND GIRLS DIVISION. YOU MUST RUN EACH DIVISION - NO EXCEPTIONS

U8 Division – Boys/Girls – Birthdate is 8/1/2015 or later U10 Division – Boys/Girls – Birthdate is 8/1/2013 Through 7/31/2015 U12 Division – Boys/Girls – Birthdate is 8/1/2011 through 7/31/2013 U15 Division – Boys/Girls – Birthdate is 8/1/2008 through 7/31/2001 U18 Division – Boys/Girls - Birthdate is 8/1/2005 through 7/31/2008

Bowlers may choose to 'bowl up' to a higher division (i.e. a bowler that is U8 division by age may elect to bowl in the U10 division). To do this a bowler and his/her parents MUST complete a PEPSI Youth Championships Waiver PRIOR TO THE FIRST BOWLING DURING YOUR QUALIFYING WINDOW.

## Please read this packet carefully

USBC is no longer providing your league level qualifying handbook in paper form. You can download the handbook from www.ilusbcyouth.org (handbooks and other resources are on the RESOURCES tab) or from <a href="https://www.bowl.com">www.bowl.com</a> (Tournaments>Youth>PEPSI Championships)

There is one (2 wk) league qualifying window (Oct. 2-15, 2023). The advancement ratio is 1:2, with at least 10 bowlers per division, per league, eligible to advance to the Zone tournament. You may request an adjustment (via your zone tournament manager) in the qualifying window as long as it does not interfere with IHSA bowlers because it is during the IHSA season or favor one group of bowlers in your league over another because of conflicts.

The U8, U10 and U12 Divisions will bowl their Zone Tournament in <u>January or early</u>
<u>February of 2024</u>. U15 and U18 Divisions will bowl their Zone Tournament in <u>late</u>
<u>February</u> or early <u>March of 2024</u>. Your Zone Tournament Manager will provide you with the exact dates for your zone in a separate mailing.

The State Tournament for the U8/U10/U12 divisions will be held at Mardi Gras Lanes in DeKalb and the U15/U18 divisions will be held at Don Carter Lanes in Rockford. The U8/U10/U12 divisions will be May 3-5, 2024. The U15/U18 Divisions will be May 10-12, 2024. Bowlers in the U12 Division MUST bowl a qualifying round on either Friday (evening squad), May 3 or Saturday, May 4 to determine semi finalists who will bowl on Sunday, May 5. Bowlers in the U15 and U18 Divisions MUST bowl a qualifying round on either Friday, May 10 (evening squad) or Saturday, May 11 to determine semi finalists who will bowl on Sunday, May 12.

# ATTENTION COACHES

We will be sending our U12, U15 and U18 winners (both boys and girls) to the 2024 Junior Gold Championships in Detroit, MI. This year we anticipate again awarding around

\$100,000

in scholarships between the zone and state tournaments. State scholarships will be dependent on the participation in each division and paying in a ratio of 1:5. For the U12, U15 and U18 divisions all bowlers that return on Sunday will receive a scholarship prize (MUST return to bowl to earn a prize).

#### STATE FINALS

- U15/U18 divisions. Bowlers will bowl six games on one of two qualifying dates (May 10 or 11, 2024). The number of bowlers advancing to Sunday will be announced prior to the tournament based on participation in all divisions. All pinfall will carry forward. Those advancing to the semi-finals will bowl five more games. The top six in each division (after semi finals) will bowl six more games of match play (20 bonus pins for winning a match) and the final rankings will be based on total pinfall plus bonus pins for all games bowled.
- U12 Divisions: Format is similar to U15/U18 Divisions. Bowlers will bowl 4 games of qualifying on May 3 or 4, 2024. The top 16 bowlers will advance to Semi Finals on Sunday, May 5, 2024 (4 games) with another cut to the top 4 for more games of match play. Final rankings will be based on total pinfall plus match play bonus pins.
- **U8/U10 Divisions:** Bowlers will bowl three games on any one day May 3-5, 2024. Final standings in each division will be based on the scratch pinfall from the series for each division.
